#### WESTMORELAND COUNTY HIGH SCHOOL

Date:02/07/2022Weather:39 degrees. Rain - High of 41 degrees today.

13:00 – 16:30hrs (3.5hrs) – Site Visit

Walked the site today.

### <u>Area A</u>

Door Hardware is being installed on various doors. Branch has moved out of room A102 and moved into A103. The floor in A102 has been prepped for tile.

# <u>Area B</u>

The Painters were painting in various areas on the 2<sup>nd</sup> floor of Area B. The epoxy floor has been completed in Room B209 where there were cracks in the concrete, (see previous report). All of the Toilet Partition & fixtures have been installed in Rooms B116, B118, B216 & B216. Industrial Concrete is pouring and finishing the Stairs and Landings in Stairwell #4.

# <u>Area C</u>

The Sprinkler sub is working in Area C. Painters are prepping and painting the Grand Staircase. They continue to work on the Acoustic Cloud Ceiling around the perimeter of Area C. Metal Panels are also being installed around vestibule C10.

# <u>Area D</u>

Acoustical Panels have been hung in rooms D122 & D127 in Area D. The painter is Painting and back rolling the West wall of the Auditorium. Electricians are working in IDF Room D111.

#### <u>Area E</u>

Hodgeman is working on Epoxy floors in E. Rooms E124, E126, E134, E135B, and E136B have been completed. Electricians are working on Emergency Exit Signage .

<u>Site</u>

**Conversations with Branch Builds**: I met with John, Lee, Jake and Chandler. I was advised that Branch and most of the Sub-Contractors have changed the work schedule beginning today. They are going to be work Monday-Thursday 10 hours days. Friday & Saturday are eight hours days for a 56 hour workweek. Chandler asked if the School hard the Hardware for mounting the Promethean Boards, Bolts, spacers, etc. I reached out to Chris Evans and he said he did not have the hardware, but he would have one complete Promethean Board with Bracket, Bolts, Spacers, etc. delivered to the site for the Mockup. What was previously delivered was a Promethean Board mounted to mobile cart.

I received a call from Todd Demetriou pertaining to the Town's \$500.00 Variance Application Fee. Permit Fees for the Project were waived in the beginning. The County has no control over the Town. I called Norm Risavi and he said he would reach out to the Town and see what could be done. The Town Manager said she would see if Town Council would waive the fee, however, there if they did there would still be a \$300.00 fee for the Advertisement of the required Public Hearing.

Compliance with Contract Documents: No noted discrepancies.

**DEQ Reports**: A re-inspection of the site was conducted on November 29<sup>th</sup>, 2021.




Photo 1 - C102 Kitchen prepped for Quarry Tile.




Photo 2 - Grand Staircase being prepped and painted




Photo 4 - West wall of Auditorium is being painted.




Photo 5 - Acoustical Panels have been installed on the west wall of D122




Photo 7 - Acoustical Panes have been hung on the East wall of D127




Photo 9 - Fluid Applied Resinous flooring - Room E134




Photo 10 - Fluid Applied Resinous Flooring - Room E135B




Photo 11 - Concrete Steps and Landings are being poured and finished in Stairwell #4




Photo 14 - Toilet Partitions have been installed in B118
