


Photo 1 – Auditorium Panelized Linear Wood Wall System




Photo 2 - Kitchen




Photo 3 - Kitchen Dry Storage




Photo 7 - Diamonds in Bathrooms. Brach says their Sub will fill Diamonds and skim coat entire floor so everything matches.





Photo 10 - Carpet is being installed in Area A - 2nd floor.






Photo 12 - Area C




Photo 14 - Front of site




Photo 15 - Locker are being installed




Photo 16 – Lockers and benches installed




Photo 17 - Locker and Benches have been installed
