	I walked the site and observed the work being performed.
	Beuchert Excavation: No one is on site today.
	Industrial Concrete: No one is on site today.
	J.D. Long, Masons: Fourteen (14) men are on site today. They continue to lay block in Area D, in the Kitchen and in D103. One man is also laying precast on the West Side of Area C. They are also power washing brick on the South side of Area B.
	Hazzard Electric: Thirteen (13) men are on site today. They continue to pull wire in Area A, B, C & D. One man continues to install Disconnects on H-frames on the roof of Area B. A couple of guys are installing conduit in the Kitchen ahead of the Mason. They are also setting Light Fixtures in Area A.
	Colonial Webb : Twenty-one (21) are on site today. They are setting three rooftop units and installing Duct in Area D, Auditorium. A crew is also running pipe in D107.
	Weldon Steel: Three (3) men are on site today. They continue to set Steel in the Auditorium.
	JP Construction: Fifteen (15) men are on site today. They are hanging ceiling grid in Area A & B and working on roof blocking in Area C.
	AAR Roofing: Five (5) men are on site today. They have begun to work on the high Roof of Area C.
	Tailored Foam: Two (2) men are on site today and are up on the low roof of Area E spraying foam.
	FG & M: Five (5) men are on site today. They continue to work on Curtain walls and are also prepping SF8 to be set.

United Sprinkler: Three (3) men are on site today. They are running Sprinkler pipe in Area D.

CTSI: Two (2) men are on site today pulling low voltage wire in various locations.

M. L. Straight: No one is on site today.

S&S Concrete Cutting Company: I did not observe anyone on site today during my visit.

Linear Surveyors: I did not observe anyone on site today.

Hillis-Carnes: I did not observe a Tech on site today.

Questions to or from Branch Builds: I met with Brian Topper this morning. He advised me that the Crane was on site this morning setting three Roof Top HVAC Units and would also be setting the Chillers this morning. He also told me that he is targeting September 1st as the date to have all of the Construction Trailers moved off site.





Photo 2 - Curb prepped to receive Rooftop HVAC Unit on the Low roof of Area D.







Photo 8 - HVAC Duct is being run above the Stage in the Auditorium.
