	JP Construction: They are hanging sheetrock in the Administrative Office area and framing and sheathing Parapet walls on the roof of Area C.
	AAR Roofing: No one is on site today.
	Tailored Foam: No one is on site today.
	FG & M: They continue to work on Curtain walls.
	United Sprinkler: They continue to run Sprinkler pipe ion the 2 nd floor of Area A.




Photo 2 - Weldon Steel is cutting and welding steel in the Auditorium




Photo 3 - Colonial Webb is running HVAC Duct in the Auditorium




Photo 5 - Sheetrock is being hung in the Administrative Office area.




Photo 7 - Cement Board has been hung in the 1st floor bathrooms in Areas A & B.
