# **Delegations/Presentations**

#### **Nominations for Character Trait**

As part of the registration, Ms. Lane received several K-12 books which she gave to Ms. Rice to distribute as needed.

Dr. Perry presented information on the current athletic fields as well as the new athletic fields. Dr. Perry stated that the solar panels are being installed at Washington District Elementary School.
