
## WESTMORELAND COUNTY SCHOOL BOARD

#### **BOARD MINUTES**

December 10, 2019

The Westmoreland County School Board held a work session on Tuesday, December 10, 2019 at 5:00 p.m. at the Gerald B. Roane Center for Excellence Building, Montross, Virginia.



Mrs. Ramsey made a motion that the Board convene into closed session as provided in Section 2.2-3711(A) of the Code of Virginia, for the purpose of discussing personnel matters dealing with specific personnel of the Westmoreland County School system pursuant to Section 2.2-3711 (A)(1) of the Code of Virginia.
