January 25, 2021

The meeting was called to order by Mr. Fallin, Chair.

Dr. Wallace read the Westmoreland County Public Schools' mission statement and vision statement to the public.

#### **Informational Items**

#### **Return To Learn**

Dr. Williams provided a brief pandemic update. Dr. Williams stated the vaccination process has started but there is a shortage of vaccine availability at this time. Dr. Williams emphasized the importance that protective measures need to stay in place even after the vaccine has been administered. The goal is to have frontline workers which includes teachers, vaccinated by the end of February.

Ms. Rice shared CDC data with the Board. Ms. Rice stated that surveys were sent out to all employees to collect data on interest for getting the vaccine. Ms. Rice also shared that surveys were sent out to parents of all virtual students asking if they want to switch to in person instruction. New interim guidance for prek-12 school opening was also shared. (Appendix IX)

### **VHSL Fall Sports**

Dr. Perry shared information on fall sports. Dr. Perry spoke with coaches and administrators and at this point the coaches and administrators need more conversation among themselves. Dr. Perry recommended that the high school be given the option of

beginning conditioning and the option to engage in fall sports if they choose based on the fact they adhere to all CDC guidelines.

Dr. Wallace made a motion to delegate authority to Dr. Perry to make the determination based upon inputs from the high school whether or when to commence practice for preparations for the sports seasons. Mrs. Lewis seconded the motion.

# **Selection of Name for New High School**

Dr. Perry read School Board Policy FFA. Dr. Perry stated that they followed this process and the Board has been given several data points. Surveys were provided, town hall meetings were held, letters, emails, phone calls and conversations with many community members were held. Mr. Fallin stated that there were three names that consistently rose to the top: Westmoreland High School, Westmoreland County High School, and Washington and Lee High School. Mr. Fallin started the process by asking if there was a motion to name the new high school Westmoreland High School.

Dr. Wallace made a motion to name the new high school Westmoreland High School. Ms. Lane seconded the motion.

The Board discussed the new high school name. Each Board member shared their reasoning for how they interpreted the data points.

Mrs. Ramsey explained her interpretation of the survey data and how it led to the conclusion to keep the name Washington and Lee High School.

Ms. Lane explained her interpretation of the survey data and the town hall conversations and concluded that Westmoreland High School should be the new name.

Mrs. Lewis stated that her interpretation of the online survey and the fact that the new school is a replacement school for Washington and Lee High School led her to conclude that Washington and Lee High School should remain the name.

Dr. Wallace stated that he focused on the online surveys and town hall meetings and concluded that Westmoreland High School should be the new name.

Mr. Fallin stated that he focused on the online surveys and town hall meetings and concluded that Westmoreland High School should be the new name.
