WESTMORELAND COUNTY SCHOOL BOARD MONTROSS, VIRGINIA BOARD MINUTES September 20, 2021

The Westmoreland County School Board met in regular session on Monday, September 20, 2021 at 6:00 p.m. at the Gerald B. Roane Center for Excellence Building, Montross, Virginia.

The meeting was called to order by Mr. Fallin, Chair.

Dr. Wallace made a motion that the Board convene into closed session as provided in Section 2.2-3711(A) of the Code of Virginia, for the purpose of discussing personnel matters dealing with specific personnel of the Westmoreland County School division pursuant to Section 2.2-3711 (A)(1) of the Code of Virginia.

Board Member Mrs. Ramsey seconded the motion.

At 6:00 p.m. the meeting was reconvened into public meeting on the motion by Board Member Dr. Wallace and seconded by Board Member Ms. Lane.

WHEREAS, the Westmoreland County School Board convened a closed meeting on this date pursuant to an affirmative recorded vote and in accordance with the provision of the Virginia Freedom of Information Act; and

WHEREAS, Section 2.2-3712(D) of the Code of Virginia requires a certification that, to the best of each member's knowledge, (i) only public business matters lawfully exempted from open meeting requirements by Virginia law were discussed in the closed meeting which this certification applies, and (ii) only such public business matters as were identified in the motion convening the closed meeting were heard, discussed, or considered.

The Board was led in prayer by Dr. Perry and the Pledge of Allegiance was recited.

Dr. Wallace read the Westmoreland County Public Schools' mission and vision statements to the public.

Approval of Agenda

The agenda was approved by unanimous consent.

Delegations/Presentations

Dr. Richard Williams, Director, Three Rivers Health District, provided an update from the Virginia Department of Health. Dr. Williams shared Three Rivers remains at the verge of overwhelming the hospitals. The Delta variant has been very impactful for children, both older children (ages 12-18) and younger children (ages 0-11). The level of transmission is high throughout the state and in Westmoreland County. Vaccination is strongly encouraged. Dr. Williams also encouraged the division to participate in the ViSSTA program.

Dr. Perry shared the attendance recognition for August. The school with the highest student attendance was Washington District Elementary with an average percentage present of 92.04%. The school with the highest staff attendance was Montross Middle School with an average percentage present of 97.09%.

Dr. Perry shared that arrangements have been made to process our bills. Approval of bills for payment will be presented at the October 18, 2021 Board meeting.

ViSSTA Program Overview

Ms. Rice presented an overview of the ViSSTA (Virginia School Screening Testing for Assurance) program. This is an optional program provided through a joint effort between the Virginia Department of Health and Virginia Department of Education. It provides free COVID-19 screening testing for students, teachers, and staff as an added layer of prevention combined with vaccination and other mitigation strategies.

Communication Forum

Ms. Rice shared the dates of the 2021-22 Communication Forum meetings: October 20, 2021; December 15, 2021; and February 16, 2022. All meetings are held at 2:00 p.m. in the Board Room. One Board member representative is needed for each meeting.

VSBA Policy Updates

Growth Assessments

Ms. Rice presented an overview of the state Growth Assessments. These assessments, new for 2021-2022, are mandated by 2021 legislation and administered to students in grades 3-8 in reading and math. The purpose of the assessments in 2021 is to provide baseline data to guide instruction and to measure individual student academic progress. Full implementation will occur beginning with 2022-2023.

Facility Update

Dr. Perry presented a Facility Update. The issues related to the parking lot and the grading of the athletic fields for the new Westmoreland High School have been resolved. Construction is on target to meet the substantial completion date of March 8, 2022. Dr. Perry recommended time be allocated in upcoming Board work sessions to discuss future use of the existing Washington & Lee High School facility and grounds. Dr. Perry shared bids have been advertised and are due October 8, 2021 at 2:00 p.m. for the renovation to the entrances of Montross Middle and Cople Elementary schools. Replacement of HVAC units at Montross Middle, Cople Elementary, and Washington District Elementary schools will begin soon, as will installation of the keyless entry system. Renovation of the bathrooms at Montross Middle will occur in Summer 2022.

School Board Member Comments

Ms. Lane inquired about avenues for staff to share feedback about how the pandemic is affecting them individually. Dr. Wallace suggested that once schools have identified gaps that need to be addressed based on data from the growth assessments, consider using community volunteers to

assist with tutoring. Mrs. Lewis noted that she does not agree with staff members being required to use their leave for the purpose of isolation or quarantine.
