Discipline Report

Dr. Perry provided the discipline report to the Board. (Appendix V)

School Lunches

Dr. Perry provided information on the price of school lunches for 2019-2020 school year. Dr. Perry stated that the school lunch price will increase by .05 cents to \$2.90. The state has increased school lunch prices for the 2019-2020 school year. Dr. Perry stated that prices will be shared with administrators to share with parents.

Virginia Defense Force Cadet Program Update

Dr. Perry provided an update on the Cadet Program. Dr. Perry stated that all necessary signatures have been obtained to proceed with the cadet program. Dr. Wallace noted that Westmoreland County Public Schools is the flagship program for the cadet program.

Strategic Plan Development

Dr. Perry provided an update on the strategic plan development meetings. Dr. Perry stated that parameters and goals have been set for the next five years. Several focus meetings have been scheduled to get input on the strategic plan. Dr. Perry stated approximately seven local businesses attended the first meeting which was held June 10, 2019.

Northern Neck Technical Center Attendance

Dr. Perry stated that Ms. Lane had requested data on the student attendance at the technical center. Dr. Perry provided data on students attending the technical center. Dr. Perry stated awards were received by several students at the completion ceremony. Ms. Lane stated that a Westmoreland student was selected as student of the year and selected to represent his peers.

W & L Class of 2019 Scholarships

Dr. Perry stated that a total of \$2,492,743.00 in scholarships was offered to the class of 2019. Mr. Fallin commented that this is a major accomplishment and a huge increase from last year. Mr. Fallin commended everyone involved in helping the students with the scholarships. Dr. Perry recognized Patty Long for her dedication to the students with the scholarships and the Gear Up program.

VSBA Policy Updates

Ms. Rice presented policy updates to the Board to review.

Facility Update

Dr. Perry presented the facility update report to the Board. Dr. Perry discussed the new high school project with the Board. Dr. Perry stated that value engineering has begun. He also stated that some items have been re-bid and the the county will have to reassess the loan amount. Mr. Fallin noted that since May 15, 2019 prices have increased. Mr. Fallin stated that Branch Builders and Grimm and Parker have been very cooperative in the value engineering process and it will still be a challenge. Dr. Perry stated that the Sun Tribe

proposal is still under negotiations. Dr. Perry shared that paving should begin soon at Cople Elementary School. (Appendix VI)
