WESTMORELAND COUNTY SCHOOL BOARD MONTROSS, VIRGINIA BOARD MINUTES September 19, 2022

The Westmoreland County School Board met in regular session on Monday, September 19, 2022 at 6:00 p.m. at the Gerald B. Roane Center for Excellence Building, Montross, Virginia.

The meeting was called to order by Mr. Fallin, Chair.

Board Member Dr. Wallace made a motion that the Board convene into closed session as provided in Section 2.2-3711(A) of the Code of Virginia, for the purpose of discussing personnel matters dealing with specific personnel of the Westmoreland County School division pursuant to Section 2.2-3711 (A)(1) of the Code of Virginia. WHEREAS, Section 2.2-3712(D) of the Code of Virginia requires a certification that, to the best of each member's knowledge, (i) only public business matters lawfully exempted from open meeting requirements by Virginia law were discussed in the closed meeting to which this certification applies, and (ii) only such public business matters as were identified in the motion convening the closed meeting were heard, discussed, or considered.

The Board was led in prayer by Dr. Perry and the Pledge of Allegiance was recited.

Dr. Wallace read the Westmoreland County Public Schools' mission and vision statements to the public.

Approval of Agenda

The agenda was approved by unanimous consent.

Delegations/Presentations

Attendance Recognition

Dr. Perry shared the attendance recognition for August. The school with the highest student attendance was Washington District Elementary with an average percentage present of 94.88%.

Character Trait Honorees

Ms. Rice presented the Character Trait honorees for the month of August and the trait of Patience. Students recognized this month included Z'kiyah Perrie in grade three at Cople Elementary School; Ari'ona Kershaw in grade three at Washington District Elementary School; Mashalyn Miles in grade nine at Westmoreland High School; and Courtney Shannon in grade six at Montross Middle School.

Bus Driver Recognition

Ms. Rice presented a statement on behalf of Terry Rich, Transportation Supervisor, in recognition of those drivers who demonstrated Punctuality during the first week of school. These drivers are being honored for their timeliness in picking up students, arriving at school and delivering the students back home. These drivers reviewed their routes in advance to lessen possible hiccups during the first week of school. They also communicated pick up and drop off times with parents and students. Bus drivers recognized were Harold Dickerson, Washington District Elementary School; Albert Henry, Montross Middle and Westmoreland High School; and Lisa McCoy, Cople Elementary School.

Fuel Bids

Dr. Perry presented information regarding fuel bids for 2022-2023. Mr. Rich, Transportation Supervisor, was ready to present the bids to the Board in July, however, it was decided to reconsider the bids based on an increase in fuel prices. NWP Energy Company, who currently provides the division's fuel, offered to continue supplying fuel at the same prices as last year. A motion was made by Board Member Dr. Wallace and seconded by Board Member Mrs. Ramsey to award the fuel bid to NWP Energy Company.

Information Items

Health Plan Update

The Health Plan has been updated and updates the information regarding quarantines, isolation, and returning to school. These updates are based on recommendations from the CDC.

Instructional Plan Update

The Return to Learning Plan has been updated to update social distancing information, quarantines, and isolation.

Accreditation Status 2022-2023

Ms. Rice presented the official school accreditation status from the Virginia Department of Education. All four schools are accredited.

Enforcement of Policy JFCF – Drugs in Schools

Dr. Perry shared information regarding the enforcement of Policy JFCF – Drugs in Schools. It has been reported that students are vaping substances that include drugs. Dr. Perry outlined strict consequences for students caught with drugs and/or vaping at school.

Cell Phone Policy

Ms. Rice presented a draft copy of the cell phone policy. The policy states that cell phones will not be allowed to be used during instructional time. It also lists consequences for violating the policy.

Communication Forum

Capital Improvement Plan Update

Dr. Perry shared the process and purpose for developing the capital improvement plan. Maintenance needs for all school and division locations were solicited. The list was prioritized according to need. He explained that the division will use federal funds to cover the cost of many of the projects. He also noted that the division will apply for future construction grants as they become available.

Facility Report

Dr. Perry shared the following information:

- There are still a few high cost items that need to be completed at Westmoreland High School
- The division has a new SRO, Master Deputy Robert Pitts. He will be located at Cople Elementary and Montross Middle Schools.
- The metal detectors have been assembled and should be operational by the next Board meeting. The division is trying to secure wheels for the detectors so they can be easily moved, and is waiting on special adapters also to make them operational.
- The division has contracted with a digital firm to do facility mapping. Once completed, there will be a meeting for critical personnel to be trained.
- The division is moving forward with the walkway canopy and outdoor learning space for the new high school. This project is being funded with federal funds.
