#### WESTMORELAND COUNTY SCHOOL BOARD MONTROSS, VIRGINIA BOARD MINUTES February 2, 2023

The Westmoreland County School Board met in regular session on Thursday, February 2, 2023 at 6:00 p.m. at the Gerald B. Roane Center for Excellence Building, Montross, Virginia.

The meeting was called to order by Mr. Fallin, Chair.

Board Member Mrs. Ramsey made a motion that the Board convene into closed session as provided in Section 2.2-3711(A) of the Code of Virginia, for the purpose of discussing personnel matters dealing with specific personnel of the Westmoreland County School division pursuant to Section 2.2-3711 (A)(1) of the Code of Virginia. Board Member Dr. Wallace seconded the motion.

WHEREAS, the Westmoreland County School Board convened a closed meeting on this date pursuant to an affirmative recorded vote and in accordance with the provision of the Virginia Freedom of Information Act; and

WHEREAS, Section 2.2-3712(D) of the Code of Virginia requires a certification that, to the best of each member's knowledge, (i) only public business matters lawfully exempted from open meeting requirements by Virginia law were discussed in the closed meeting to which this certification applies, and (ii) only such public business matters as were identified in the motion convening the closed meeting were heard, discussed, or considered.

## **Organization of the Board**

Superintendent Dr. Perry took the gavel and presided over the Board as they prepared to organize for the new year.

Dr. Perry asked if there were any nominations for Board Chair. Board Member Dr. Wallace nominated Mr. Fallin for the position of Board Chair. Member Dr. Wallace made a motion to close the nominations and was seconded by Board Member Mrs. Ramsey. After the vote Superintendent Perry asked all in favor of Ralph Fallin and the vote was unanimous. Ms. Rice presented the Character Trait honorees for the month of December. The trait of the month was Kindness. Students recognized this month included Josselyn Rodriquez-Chicas in grade twelve at Westmoreland High School; Wesley Fairfax in grade seven at Montross Middle School; Ky'Lan Newman in grade five at Cople Elementary School; and Mason Oceguera in grade four at Washington District Elementary School.

#### **Bus Driver Recognition**

Mr. Rich, Transportation Supervisor, presented three transportation aides with the Positive Attitude Award. This award recognizes transportation employees who create a great work environment between co-workers and administrators. The transportation aides who received this award were Annie Johnson at Washington District Elementary School, Janice Page at Cople Elementary School, and Patricia Henry at Montross Middle School and Westmoreland High School.

## Virginia Principals Appreciation Week

Superintendent Dr. Perry shared that the Governor of Virginia designated January 15-21, 2023 as Virginia School Principals Appreciation Week. He then introduced all Principals by inviting them to stand. Deputy Superintendent Ms. Rice read the Certificate of Recognition signed by Governor Glenn Youngkin. Each Principal and Assistant Principal received a gift of appreciation.

#### **School Board Book Study**

Vice Chair Ms. Lane shared that VSBA had a book study during the Annual Conference in November. As a board, it was decided to read the book *Stick Together, A Simple Lesson to Build a Stronger Team*. This book study will be used during the Professional Development to maintain Master Board Certification.

#### Board Development with VSBA – April 14, 2023

Board Chair Mr. Fallin shared that Westmoreland County School Board was the first school Board in Virginia to receive the Master Board Certification. An annual self-evaluation is required. As a result, April 14, 2023 has been agreed upon to hold this training.

#### **VDOE Calc Tool**

Deputy Superintendent Ms. Rice shared information regarding the VA Calc Tool provided by the Virginia Department of Education. For the first time, the tool gave divisions information that derived from a flawed formula. If nothing changes, this will result in overstated Basic Aid funding. Ms. Rice also shared the financial impact this error will have on the Westmoreland County School Board Budget for the current year and fiscal year 2024. The Virginia Department of Education, General Assembly are aware of the error and we are waiting to see what comes from this attention to the error.

#### Fighting and Threat of Weapons

Superintendent Dr. Perry shared the school's processes for addressing fights and weapons in this division. Dr. Perry gave a presentation that included Board policies, school procedures based upon policy, Crisis Plan Overview, and Communication procedures before, during, and after disruptive events.

#### **Facility Report**

Dr. Perry shared the following information:

- Football Stadium The goal was to be able to play our games at Westmoreland High School next year. However, due to the supply chain, this may not happen.
- Concession Stand and Weight Room Still working on this.
- Marque Concern that it is not straight. It will never be straight because everything else is at an angle.
- Fence Shared a diagram showing where the fence will be.
