# WESTMORELAND COUNTY SCHOOL BOARD MONTROSS, VIRGINIA BOARD MINUTES March 21, 2022

The Westmoreland County School Board met in regular session on Monday, March 21, 2022 at 6:00 p.m. at the Gerald B. Roane Center for Excellence Building, Montross, Virginia.

The meeting was called to order by Mr. Fallin, Chair.

# Washington & Lee HS Boys Varsity Basketball Team & Coach, Nicolas Hall Dr. Perry introduced Nick Hall, Coach of the Varsity Boys Basketball Team. Coach Hall shared that it has been 24 years since our basketball team has made it to the state tournament. Coach Hall introduced members of the team and shared that seven to eight players were all academic.
